Three Rivers Park District is seeking to fill two **Greenskeeper** positions, one at Glen Lake Golf and Practice Center (.65) in Minnetonka, MN and Hyland Hills Ski Area (.35) in Bloomington, MN and one at Hyland Greens Golf Course (.65) and Hyland Hills Ski Area (.35) in Bloomington, MN. These are year-round full-time benefitted positions. During the golf season, these positions are responsible for performing technical golf course maintenance tasks under minimum supervision with an emphasis on irrigation, chemical application, cultural practices, and the skilled use of specialized equipment. During the winter, these positions will perform maintenance duties to support outside downhill operations including snow making, grooming, vertical lift maintenance, and the operation of specialized equipment. Successful candidates will be placed on an eligibility list from which future vacancies may be filled.

Three Rivers Park District operates six golf facilities including; Baker National Golf Course in Medina, Eagle Lake Golf Course and Parkers Lake Driving Range in Plymouth, Glen Lake Golf Course in Eden Prairie, Hyland Greens Golf Course in Bloomington, and Cleary Lake Golf Course in Prior Lake.
